THE NEXT PHASES COMITE FLATS I AND COMITE FLATS II ARE COM-PLETE. APPROXIMATELY 110,000 BOTTOMLAND HARDWOOD SEEDLINGS WERE PLANTED ON THE 208 ACRE SITE. ECOSYSTEM RENEWAL IS EXICTED TO ANNOUCED THAT 52.3 MITIGATION ACRES AT COMITE FLATS I AND 48.4 MITIGATION ACRES AT COMITE FLATS II WERE JUST RELEASED FOR SALE.
